Post-Results Services: Enquiries about results (EARs) & Access to scripts (ATS)

EAR Service 1 – Clerical Re-check

Deadline: 20 September 2018

This is a re-check of all clerical procedures leading to the issue of a result. This service will include the following checks:

- that all parts of the script have been marked;
- the totalling of marks;
- the recording of marks;

Can only be requested for objective tested (multiple choice tests). Candidate consent required.

EAR Service 2 – Post-Results Review of Marking

Deadline: 20 September 2018

This is a post-results review of the original marking to ensure that the agree mark scheme has been applied correctly. It is not a re-marking of the candidate's script. This service will include:

- the clerical re-checks detailed in Service 1;
- a review of marking as described above;

This is available for externally assessed components of both unitised and linear specifications. Candidate consent required.

EAR Priority Service 2 – Post-Results Review of Marking

Deadline: 23 August 2018

This is a priority post-results review of the original marking to ensure that the agree mark scheme has been applied correctly. It is not a re-marking of the candidate's script. This is available for externally assessed components of both unitised and linear GCE specifications. It is only available if a GCE A-level candidate's place in higher education is dependent on the outcome. Candidate consent required.

Access to Scripts – Priority

Deadline: GCE 24 August 2018 / GCSE 30 August 2018

This service is to request a copy of a script to help decide if an EAR Service 1 or 2 should be applied for; this service is not available if an EAR priority service 2 is applied for. Copies will be returned no later than 6 September 2018. Candidate consent required.

Access to Scripts – Original

Deadline: 27 September 2018

This service is to request the original script to be returned. This service is available to individual candidates or centre staff (subject to candidate permission). Original or an electronic image of the script will be returned between 27 September and 3 November. Candidate consent required.
